SAICA congratulates candidates who achieved success in the 2023 APC

Johannesburg, Friday 23 February 2024 – Today, the South African Institute of Chartered Accountants (SAICA) announced that 2 266 (52%) of the 4 348 candidates who wrote the Assessment of Professional Competence (APC) in December 2023, successfully demonstrated their competence in the assessment. The APC is the final assessment in which candidates must demonstrate their professional competence to be eligible to register as Chartered Accountants.

SAICA's Chief Executive Officer, Patricia Stock, expressed her heartfelt congratulations to the candidates who exhibited unwavering determination and successfully applied themselves to the professional requirements of the APC. "These candidates have shown exceptional resilience, navigating complexities with determination."

Exceptional performance honoured

SAICA extends a special word of congratulations to the 10 candidates who earned a place on SAICA's prestigious APC Honours Roll. An overview of the results

The candidates who were writing the APC for the first time in December 2023 outperformed those candidates who were repeating the APC, the first-time candidates achieved a 63% pass rate, while repeat candidates achieved a 38% pass rate. This is clear evidence that more needs to be done to support candidates who are repeating the APC.

Stock encourages those who did not succeed to view this as a stepping stone, stating, "I appeal to all the candidates who did not succeed in this sitting to view this experience as an opportunity for growth and to be a student of their results in order to identify areas of focus in order to accordingly adapt learning and preparation strategies. Your hard work is commendable. Failure does not define you and I encourage you to persist on your path to success."

Stock further emphasised "while we celebrate the accomplishments of those who succeeded, we recognise the immense efforts put forth by every candidate. SAICA remains committed to the continuous development of human capital, understanding that each candidate's journey is distinct, and success is achieved through perseverance and learning".

The road to transformation continues

SAICA continues to be concerned about the differential in the pass rates for the demographic groups. SAICA continues to engage actively with key stakeholders to address the differential in pass rates. A review to understand the root causes of the gaps in pass rates of different race groups is underway. Once the review is concluded, the relevant learning and development governance structures will consider the steps that should be taken to address the challenges with the pass rates.
