- (1) Prompt payment of assessments by employers will assist this office in reducing administration costs to a minimum and to avoid consequent increases in the rate of assessment. Interest charged is based on prevailing market rates and subject to change.
 - (2) Penalties which can be imposed:
 - (a) For late or non-remittance of return of earnings. A penalty not exceeding ten percent (10%) of the assessment levied [Section 83(6)].
 - (b) For understatement of earnings actually paid. A penalty not exceeding ten percent (10%) of the difference between the amount of earnings shown on the return of earnings and the amount actually paid [Section 82(3)].
 - (c) For failure to pay assessment on or before the due date.
 - (i) A penalty not exceeding ten percent (10%) of the unpaid amount [Section 87(1)].
 - (ii) A penalty not exceeding the full amount of the compensation award to the employees as a result of accidents occurring during this period of the employer's default [Section 87(2)].
- MINIMUM ASSESSMENT: As a result of continuously rising costs, a minimum assessment is applied annually as determined by the Commissioner.
 IMPORTANT: Change of address must be done under separate cover. No receipts will be issued i.r.o payments by cheque. The obligation to pay the above amount is not deferred or suspended by an appeal or an objection lodged in terms of Section 91(6). See also note 2(c) above.
 (3) If an error is detected after submitting your ROE, you have 60 days from the date assessed to apply for the revision of the assessment. The application must be forwarded to cfcallcentre@labour.gov.za by completing the CF-2B Form.
 (4) Employers to notify CF when the business has ceased to operate or have no employees within 7 days by completing the CF-1C Form and forward to cfcallcentre@labour.gov.za
